

AN ORDINANCE OF THE BOROUGH OF ISLAND HEIGHTS, OCEAN COUNTY, NEW JERSEY, IDENTIFYING AND NAMING EAST CAMP WALK AND A PORTION OF WEST CAMP WALK

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Island Heights, County of Ocean, and State of New Jersey, as follows:

SECTION 1. Purpose. The purpose of the within Ordinance is to identify and clarify the area known as East Camp Walk, also known as Camp Meeting Avenue and a portion of West Camp Walk, otherwise referred to as Camp Walk.

SECTION 2. The area of roadway commencing approximately 105' south of the northwest corner of Highland Bend and Ocean Avenue and running generally in a westerly direction approximately 395' and terminating on the westerly boundary line of Block 27.01 shall be known as East Camp Walk.

SECTION 3. The area of roadway being 25' wide commencing on the east side of Simpson Avenue and beginning at a point approximately 200' from the southeast corner of Simpson and Ocean Avenue and running thence in a easterly direction approximately 280' to a point parallel with the easterly side line of Lot 6, Block 27.04 shall be known as West Camp Walk.

SECTION 4. This Ordinance repeals any inconsistent ordinance or ordinances or part or parts thereof.

SECTION 5. This Ordinance shall take effect immediately upon its final passage and publication as required by law.
