He further stated that this is to close the Public Hearing to the Municipal Budget and carry the Budget hearing to the August 18, 2015 meeting at 6:30pm at which a new, amended Budget will be presented with a new Public Hearing as per State Statute.

The Municipal Clerk opened the Public Hearing for the Comcast renewal and introduced Robert Clifton.

Mr. Clifton read the following statement: We are nearing the end of a three-year federally mandated process, which began when I submitted a "626" letter to the Borough, and basically that is section 626 of the FCC Code which governs Franchise renewals. The current Certificate of Approval will expire on December 11th of this year. The Certificate of Approval is a document that a cable company needs in order to operate a cable television system here in New Jersey. The Board of Public Utilities issues it after Municipal Consent and the cable company's application has been reviewed for compliance with Federal requirements. On March 11th of this year, we filed the application, which I believe that you've all seen and the attorney has a copy of,

and that basically shows our technical capabilities here in the municipality, as well as our Financials, Board of Directors, channel line-up and general information about the company's operations. Upon the close of the Public Hearing, the town would have thirty days to issue a Consent Ordinance or a Resolution of Denial. Now this timeframe is flexible and is only put in there if neither party is willing to sit down to talk. So, when the Public Hearing is closed tonight, we don't have to do it in thirty days, we just have to be able to talk. The Board of Public Utilities doesn't even ask for a formal request to extend that period of time. It's only enforced when either the municipality or the cable company goes to the BPU and says that the other party refuses to sit down and negotiate, and at that point they would step in and bring us together to talk. The Consent Ordinance which we would like is a simple "Right-of-Way". It is not a contract that obligates the town to do anything except allow us to run our plants along your rights-of-way. It is non exclusive, meaning that any other cable provider can come in at any time and seek the rights to offer service. The municipality must, however, consider out application on its own merits and not compare it to another provider. Back in 2006, this process changed dramatically when the State of New Jersey passed legislation that was signed into law that allowed for a statewide cable franchise and what that it is that a cable operator can, instead of coming here, providing an application and negotiating with the municipality, they can send an application to the Board of Public Utilities and have them approve a cable operator's ability to operate here in New Jersey. That is the method that Verizon has chosen and they're operating here in Ocean County under that where they've gone to the State to get their franchise. We also have that option, if we so chose, but for the nine years that it's been an option, we have not done that. We have good relationships with our municipalities and we believe that every municipality's cable needs are different and we like to negotiate face-to-face with the municipalities. The Governing Body must judge our application (and this is under State and Federal law) on four criteria: 1) has the cable operator substantially complied with the terms of the existing franchise? 2) Has the quality of the operator's service been reasonable in light of the community's needs? 3) Does the operator have the financial ability and technical ability to provide the services? 4) Is the franchise renewal proposal reasonable to meet the future cablerelated needs of the community? There are two areas (and this is from the State and Federal Statutes) that you cannot judge our application on: 1) our rates (they are governed by the State and Federal Governments) and 2) our channel lineup (channel line-ups are like newspaper content and protected under First Amendment rights to set up our channels as we see fit). That, however, is 99% of the questions we get asked are in rates and channel issues. So I have no problem answering any questions regarding those questions you might have. The next point would be for me to sit down with whomever the Council designates as a negotiator, whether it's a committee, or members of the administration, the Mayor or members of the Council, to discuss renewal of the franchise. The franchise has become very boilerplate, most of which is included within it has been prescribed by State or Federal law, such as the amount of bond we must post, the amount of insurance we must carry to operate here in town. There are two areas that are negotiable. One is the length of the term – how long the town is willing to give us. The other is what we can provide to the town in terms of free cable service or technology grants. Those are the things that we can negotiate with the committee. At this point, I'll answer any questions that you may have.

Mayor Silver asked what the average length of the contract?

Mr. Clifton stated that the average length in New Jersey is twenty-two year. The automatic tenure kicks in after a review by the town; usually three years before the contract ends, longest contract is 15 years. Therefore, the contract would be fifteen years and a ten year automatic renewal extension. If Comcast met all of the franchise agreement, they would be granted the ten year extension. The larger the contract, the larger the grant amount provided to the municipality by Comcast. Under the statewide franchise, which they've never used, is when neither party can come to an agreement, and the contract is for seven years; with no grant money. Comcast provides 2% franchise fees of every residence of basic cable. Once Verizon is able to provide for 60% of community, then the franchise fees would equal there, equaling 3.5%. Mr. Clifton assumes that Verizon is at the 60% capability; however he would have to check on that. The incumbent would stay at the rate until the 60% threshold was achieved.

Mayor Silver: when you talked about the length of term, what was past practice from other municipalities?

Clifton will send examples after going through neighboring municipalities.

Mayor Silver asked about the proof of performance, and Mr. Clifton stated that this is if there was an automatic renewal, which there is not. About three years before the expiration of the contract, the letter would be sent out stating they believe they have met all criteria. Mayor Silver also stated that the grants are related to the size of the municipality, and there is a resident in the audience interested in a public access channel. Mr. Clifton stated that this is something the Borough would negotiate based on the contract.

Councilmen Pillion: What are the pros and cons about having a public access channel?

Mr. Clifton: From the Comcast side, it's expensive to build the infrastructure but it's built into the cost of doing business. From the municipality side, it's maintaining it. Other towns have a line-item of \$350,000 to just maintain it. Others have mobile vans to broadcast events. Other towns have even had Comcast build a channel and it sits with a dark screen Comcast will build it but does not maintain it. The line goes to Comcast and it's sent out by Island Heights. A computer, DVD and character generator is all that is needed from the town to start

Councilmen Pillion: Are there requirements to provide content to town regardless of what the content may be?

Mr. Clifton: no. all the cable provider has to provide is least access. You just can't sell anything and no profanity. We have the capability to monitor the content but most likely it would be in reaction of a complaint. There are companies that provide content, with PBS type content as an option to the town.

Mayor Silver: what's the timeframe for negotiations?

Mr. Clifton: As long as we're talking, the Board of Public Utilities doesn't get involved, and I'm willing to meet at your convenience. Most of the contract is boiler plate mandated by BPU.

Councilman Pillion: my biggest concern is the loss of service, which occurs so often, it's frustrating.

Mr. Clifton explained that the CEO is shifting their focus towards customer service.

Councilman Pillion asked if performance benchmarks have ever been built into contracts?

Mr. Clifton stated BPU wouldn't allow it.
